


#### 36" WAS Mainline - Affected Locations









## West Path Capacity Update







- Engineering Assessment and initial remediation complete for RDR and ER crossings
  - RDR returned to operation at full MOP, 2013-09-28
     ALTBC delivery capacity increased from 54 to 62.5 106m3/day
  - ER return to service dependent on TPC return to service
- Engineering assessment for TPC and WC in progress
  - TPC initial remediation and return to service expected by Nov. 30/13
     ALTBC delivery capacity increase of 4.5 106m3/day
  - ALTBC delivery capacity increase associated with WC is less than 1 10<sup>6</sup>m<sup>3</sup>/day
- Full remediation plans for all crossing are under development
  - Service interruptions (if any) will be scheduled appropriately and minimized

#### Foothills BC and SK Capacity Update







- Foothills BC (Zone 8) pipe maintenance through Oct 30, 2013
  - Planned and necessary investigative digs and pipe replacements
     ALTBC <u>receipt capacity</u> reduced to 50 10<sup>6</sup>m<sup>3</sup>/day
  - Capacity may be slightly higher from day-to-day
  - Predicting timelines very difficult due to challenging work site conditions
- Foothills SK (Zone 9) capacity more or less uninterrupted
