**NOVA Gas Transmission Ltd. (NGTL) – Tariff Amendments related to
Measurement Canada Bulletin G-14 as accompanied by Tolls, Tariff,
Facilities and Procedures Committee (TTFP) Resolution T2009-02**

On 20 July 2009, NGTL filed an application pursuant to section 19 and Part IV of the *National Energy Board Act*. NGTL requested approval of tariff amendments related to Measurement Canada Bulletin G-14. The Bulletin set out terms and conditions under which meter owners could apply for and obtain permission from Measurement Canada to implement low intervention measurement procedures, including the requirement for certain provisions to be added to the tariff.

The Board notes that the application was accompanied by TTFP Resolution T2009-02 which indicated that the proposed amendments were unopposed by the TTFP. The Board has examined the application and has decided to approve the tariff amendments as filed on an interim basis.

NGTL is directed to serve a copy of this letter and the enclosed Amending Order AO-2-TGI-01-2009 on all of its Alberta System Shippers, TTFP members and any other interested persons.

ORDER A0-2-TGI-01-2009

IN THE MATTER OF the *National Energy Board Act* (Act) and the regulations made thereunder; and

IN THE MATTER OF an application by NOVA Gas Transmission Ltd. (NGTL) pursuant to section 19 and Part IV of the Act filed with the National Energy Board under File OF-Tolls-Group1-N081-2009-03 01.

BEFORE the Board on 30 July 2009.

WHEREAS tolls for the Alberta System have been in effect on an interim basis since 29 April 2009 pursuant to Board Order TGI-01-2009 dated 27 April 2009;

AND WHEREAS the Board issued Amending Order AO-1-TGI-01-2009 on 26 June 2009;

AND WHEREAS NGTL filed an application dated 20 July 2009 to add provisions to NGTL's Alberta System Gas Transportation Tariff that are related to Measurement Canada Bulletin G-14;

AND WHEREAS the proposed tariff amendments were unopposed by NGTL's Tolls, Tariff, Facilities and Procedures Committee;

AND WHEREAS the Board has considered the application and has decided to approve the application as filed;

THEREFORE IT IS ORDERED pursuant to section 19 and Part IV of the Act, that:

1. the proposed amendments to the tariff related to Measurement Canada Bulletin G-14 are approved on an interim basis effective immediately;
2. the tolls to be charged on an interim basis in accordance with TGI-01-2009 as amended shall remain in effect until replaced by tolls approved by the Board in a subsequent or amending toll order.
