**NOVA GAS TRANSMISSION LTD. (NGTL)
TOLLS, TARIFF, FACILITIES AND PROCEDURES COMMITTEE (TTFP)
RESOLUTION BPC02-02 – TITLE TRANSFERS
INFORMATION FILING
APPLICATION NO. 1374355**

NGTL's filing of the above-mentioned resolution, attached to your letter dated December 9, 2004, is accepted as a filing for information. It is noted that in resolution BPC02-02, the TTFP supported repealing a previously supported amendment to the NOVA Inventory Transfer (NIT) timelines in Resolution 2000-01. NGTL submitted that the discussions resulted in the conclusion that the change adopted for NIT timelines would not be beneficial and possibly even detrimental to the functioning of the NIT market.

The Board notes that the Tolls, Tariffs, and Procedures Committee (TTP), predecessor to the Tolls, Tariffs, Facilities and Procedures Committee, supported a number of business process changes through an unopposed vote on Resolution T2000-01. Resolution T2000-01 was filed with the Board for information on June 22, 2000 and subsequently acknowledged by the Board as a filing for information on July 7, 2000. As part of Resolution T2000-01, the TTP agreed that NGTL would provide Customers six effective times for NITs as described in point 11 of the 'Highlights of the Business Process Change' of Resolution T2000-01. The TTP agreed that NGTL would provide notification of implementation prior to implementing the agreed to business process changes. The TTP adopted Issue BPC02-02 on January 7, 2003, for the purpose of discussing business process changes related to Resolution T2000-01 as well as other suggested modifications to the title transfer process.

On February 4, 2004, NGTL applied to the Board for approval to continue negotiations related to this Issue BPC02-02 pursuant to the Board's Information Letter IL98-4 Revised Negotiated Settlement Guidelines (*Revised Guidelines*) and the Board's August 28, 2003 letter regarding the application of the *Revised Guidelines* to NGTL. The request was approved on February 26, 2004.

The Board notes that this resolution was approved through an unopposed vote on November 23, 2004.

It is understood that NGTL has provided notice of this resolution to its shippers and to members of the Tolls, Tariff, Facilities and Procedures Committee via the TransCanada Alberta System website. NGTL is directed to advise shippers and the TTFP of this letter in similar fashion.
