NOTICE OF APPLICATION**APPLICATION NO. 1380011****NOVA GAS TRANSMISSION LTD. (NGTL)****TOLLS, TARIFF, FACILITIES AND PROCEDURES COMMITTEE (TTFP)****RESOLUTION T2004-06 – FIRM TRANSPORTATION RECEIPT NON-RENEWABLE (FT-RN) SERVICE MODIFICATION**

Take Notice that NOVA Gas Transmission Ltd. (NGTL) has filed an application with the Alberta Energy and Utilities Board (EUB or the Board) under Part 4 of the *Gas Utilities Act*, R.S.A. 2000, c. G-5, as amended, by letter dated January 12, 2005, for approval of amendments to NGTL's Gas Transportation Tariff (Tariff) related to Firm Transportation Receipt Non-Renewable (FT-RN) service modifications (the Application). NGTL submits the changes are required to amend the minimum contract term required for FT-RN service such that the total term will not be less than one month, and the total term subscribed will be for the entire available block to a maximum of one year.

Nature of the Application

On November 23, 2004, the Tolls, Tariffs, Facilities & Procedures Committee (TTFP) adopted Issue T2004-06 for the purpose of reviewing the terms of FT-RN service. NGTL filed a request to commence negotiations on Issue T2004-06 on December 1, 2004 submitting that these discussions could result in changes to the terms of FT-RN service. The Board approved NGTL's request on December 9, 2004.

NGTL submitted that subsequent to the adoption of Issue T2004-06, the TTFP met once to discuss possible modifications to FT-RN service and recommended that minimum term requirements for FT-RN service be amended, such that the total term for FT-RN service will not be less than one month and the total term subscribed for will be for the entire available period to a maximum of one year.

NGTL further submitted that the modifications to FT-RN service will provide shippers with an option of contracting for firm service at receipt points where capacity may only exist for short periods of time, versus transporting gas on an interruptible basis which is subject to restriction.

In the Application, NGTL submitted that on January 11, 2005, the TTFP supported amendments to the Tariff related to FT-RN service modifications through an unopposed vote on Resolution T2004-06.
