Revised Negotiated Settlement Guidelines (Revised Guidelines)

2006 Compliance Filing and Request to Negotiate

Pursuant to the Alberta Energy and Utilities Board's (Board) *Revised Guidelines* and the Board's letter dated August 28, 2003, regarding the application of the *Revised Guidelines* to NGTL, NGTL hereby applies for blanket approval for 2006 to commence negotiations on routine issues adopted by the Tolls, Tariff, Facilities and Procedures Committee (TTFP). NGTL will apply separately for approval to negotiate non-routine issues as they are adopted by the TTFP throughout 2006.

The TTFP is a forum for industry stakeholders to influence natural gas transportation services on the Alberta System. The TTFP addresses issues that include, but are not limited to, the Alberta System's revenue requirement, service offerings, term and conditions of service, Gas Transportation Tariff, operating procedures, Annual Plan, facility design criteria and philosophy, and natural gas supply/demand forecasts.

Routine issues would typically include business process changes, procedures reviews, contracting practices, audits, and new services with small revenue requirement implications, the resolution of which would result in either a filing for information or an application for Board approval. Nonroutine issues would include any issue with significant revenue requirement implications, rate design or cost accountability issues, the resolution of which would result in an application for Board approval.

Invitations to join the TTFP were published in the Calgary Herald, the Edmonton Journal, the Globe and Mail, and the Daily Oil Bulletin on December 13, 2005. In addition, members of the 2005 TTFP were provided copies of these notices by way of e-mail on December 13, 2005. Parties may join the TTFP at any time throughout the year.

In its letter dated August 28, 2003, the Board directed NGTL to provide the Board with a copy of the most recent public invitation to join the TTFP at the same time that NGTL requests approval to commence negotiations for the upcoming year. Further, the Board directed NGTL to provide the TTFP membership list as proof of negotiating authority. NGTL is complying with these directives by attaching to this letter a copy of the invitation to join the 2006 TTFP and a copy of the 2006 TTFP membership list as of January 17, 2006.

NGTL respectfully requests that the Board render a decision on this application by February 13, 2006 as the next meeting of the TTFP is scheduled for February 14, 2006.
