**Take Notice** that NOVA Gas Transmission Ltd. (NGTL), a wholly owned subsidiary of TransCanada Pipelines Limited, applied to the Alberta Energy and Utilities Board (Board), on March 14, 2006 for the approval of final 2005 rates, tolls and charges for Alberta System services provided by NGTL from January 1, 2005 to December 31, 2005 (the Application). The Application was revised on March 16, 2006 as Application No. 1452692 (the Revision). NGTL provided updates to Appendix to reflect service changes approved during 2005. The original Notice dated March 22, 2006 did not indicate that the Revision had been filed. This notice is to ensure that all parties have had the opportunity to review the correct requested final 2005 rates, tolls and charges for the Alberta System. Application No. 1452114 has been updated to include the Revision and is now the Revised Application.

## **Nature of the Application**

Board Order U2004-446, issued December 14, 2004, approved NGTL's 2005 interim rates, tolls and charges. In Decision 2005-057, the Board approved NGTL's revenue requirement for 2005, 2006 and 2007, whereby the 2005 revenue requirement was set at \$1,160.0 million and deferral accounts were established for Revenue, CO<sub>2</sub> Management Service, and Flow-through Costs. The balances of these deferral accounts were to be included in the calculation of the subsequent year's revenue requirement.

Board Decision 2006-010, issued February 21, 2006, approved NGTL's rate design methodology for its 2005 rates for Alberta System services as well as the implementation and use of an energy basis for existing and new export delivery services.

In the Application, filed in compliance with Decision 2006-010, NGTL requested that the Board approve the 2005 Interim Rates as 2005 Final Rates with the following deferral account balances, including carrying costs, be included in 2006 rates:

(\$ 1.4 million)
(\$75.4 million)
