UPDATED 2008 AND 2009 TABLES OF RATES, TOLLS, AND CHARGES**

**Take Notice** that NOVA Gas Transmission Ltd. (NGTL) filed an application (Application) on January 27, 2009, with the Alberta Utilities Commission (AUC or the Commission).

### **Nature of the Application**

NGTL has applied to the AUC under the *Alberta Utilities Commission Act* and the *Gas Utilities Act* for approval of an updated Attachment 1 to the Tariff for the 2009 Tables of Rates, Tolls and Charges to incorporate the rates for the Pete Lake South station.

The 2009 FT-R Demand and IT-R rates for this station are provided in the table below:

NGTL submitted these rates were determined in accordance with the receipt-point pricing methodology that the Alberta Energy and Utilities Board (EUB) approved in [Decision 2006-010](#). NGTL has asked for approval of the updated Attachment 1 by February 16, 2009.

### **Intervention in the Proceeding**

Any party who wishes to intervene in this Proceeding must submit a Statement of Intent to Participate (SIP) to the Commission by the participation closing deadline of **4:00 pm, February 9, 2009**.

The SIP should note the applicable application number and the proceeding ID in the subject line and set out the name of the party or organization name, address or legal land description, telephone number and e-mail address (if available).

The SIP submission must also contain:

- a description of the nature of the party's interest in the proceeding (i.e. how the party will be affected by the Commission's decision);
- an indication as to whether the party supports or objects to the Application, and the supporting rationale.

If a party is represented by another party, the contact information for the representative should be included. If the SIP is being submitted on behalf of a group, the contact person for the group and the details on the group members should be provided. Submissions should be addressed to the AUC.

Subject to the *Freedom of Information and Protection of Privacy Act*, all documents filed in respect of a Proceeding, including any documents filed prior to the start of a Proceeding, must be placed on the public record. Your SIP letter and any other documents you file will be accessible to the public and all other participants in the proceeding through the Proceeding Search system on the AUC website. Please ensure that any document you file is free of information that you do not want to appear on a public record. If you do not want your document or part thereof placed on the public record, you must apply to the Commission under section 13 of the *AUC Rules of Practice* for a confidentiality order before you file your document.

### **AUC Procedures**

If a submission is filed, the AUC may grant the application without a hearing, or any additional process, if:

- (a) the Commission considers the submission to be frivolous, vexatious or of little merit; or
- (b) the person filing the submission has not demonstrated that the person may be directly and adversely affected by a decision of the Commission on the proceeding.
