ORDER TGI-01-2009

IN THE MATTER OF the *National Energy Board Act* (Act) and the regulations made thereunder; and

IN THE MATTER OF an application filed by NOVA Gas Transmission Ltd. (NGTL) with the National Energy Board pursuant to subsection 19(2) and paragraph 60(1)(b) of the Act filed under File OF-Tolls-TollsGen-N081-2009-01 01.

BEFORE the Board on 27 April 2009.

WHEREAS NGTL filed an application dated 17 April 2009 for tolls on the Alberta System to be charged on an interim basis effective on 29 April 2009;

AND WHEREAS the Board made a Declaratory Order pursuant to subsection 12(2) of the Act that the Alberta System is within Canadian federal jurisdiction and subject to regulation by the Board;

AND WHEREAS the Board determined that the operation of the Alberta System is required by the present and future public convenience and necessity and issued Certificate of Public Convenience and Necessity GC-113 dated 15 April 2009 to NGTL;

AND WHEREAS the effective date of Certificate GC-113 is 29 April 2009;

AND WHEREAS the Alberta System is regulated by the Alberta Utilities Commission until the effective date of Certificate GC-113;

AND WHEREAS tolls on the Alberta System have been in effect on an interim basis since 1 January 2009 pursuant to Alberta Utilities Commission Order U2008-385 dated 22 December 2008;

AND WHEREAS the Board has considered the application and has decided to approve the application as filed;

THEREFORE IT IS ORDERED pursuant to subsection 19(2) and Part IV of the Act, that:

1. The proposed Alberta System tolls, as contained in the Table of Rates, Tolls and Charges forming part of the Gas Transportation Tariff of NGTL filed with the Board on 17 April 2009 are approved to be charged on an interim basis effective 29 April 2009; and

2. The tolls to be charged on an interim basis in accordance with this Order shall remain in effect until replaced by tolls approved by the Board in a subsequent or amending toll order.
