8.) If you are submitting bids that are conditional on each other click Yes. Next enter the number of total conditional bids that will be submitted.

Example: [Empress to Emerson 1] then [Emerson 1 to Union CDA]. This equals 2 conditional bids.

For conditional bid Empress to Emerson 1 this equals Bid: 1 of 2. For conditional bid Emerson 1 to Union CDA this equals Bid: 2 of 2.
