Mainline Firm Service Renewal Notice Reference Sheet

Updated October 2, 2025

Background

As part of the 2021-2026 Mainline Settlement approved by the Canada Energy Regulator (CER) on April 17, 2020, Tariff amendments were made to the Firm Service Toll Schedules listed below to temporarily reduce the renewal notice provision from 24-months to 12-months. These Tariff amendments apply until October 31, 2026.

Implementation

The amendments were applied to the EMB Toll Schedule, FT Toll Schedule, FT-SN Toll Schedule, SNB Toll Schedule, STS Toll Schedule and STS-L Toll Schedule effective April 21, 2020 until October 31, 2026.

Under the temporary provision, TCPL will need to receive written notice from Customer of Customer's election to exercise their renewal options no less than twelve (12) consecutive months before the termination date under their Contracts.
