**Re: NOVA Gas Transmission Ltd. (NGTL)  
Tolls, Tariff, Facilities and Procedures Committee (TTFP)  
Resolution T2002-06 – Contract Conversion to Energy**

NGTL advises the Board that the Tolls, Tariff, Facilities and Procedure Committee (TTFP) was unable to reach consensus on Resolution T2002-06 in respect of the conversion of volume contracts to energy contracts at export delivery points on the Alberta System. It is NGTL's current intention to apply for the conversion of volume contracts to energy contracts as part of its 2005 General Rate Application – Phase 2.

Issue T2002-06 was adopted by the Tolls, Tariff and Procedures Committee, predecessor to the TTFP on November 13, 2002 and was placed in abeyance in June 2003 until September 2004. As Issue T2002-06 was adopted prior to the issuance of Board Informational Letter IL 98-4 Revised Negotiated Settlement Guidelines (*Revised Guidelines*) and the Board's letter dated August 28, 2003 regarding the application of the *Revised Guidelines* to NGTL, NGTL did not seek Board approval to negotiate. However, Board staff attended a meeting to evaluate the fairness of the negotiated settlement process related to Issue T2002-06 on March 8, 2005.
