PRESSURE/TEMPERATURE SERVICE (PT SERVICE)**

**Take Notice** that NOVA Gas Transmission Ltd. (NGTL) has filed an application (the Application) with the Alberta Energy and Utilities Board (EUB or the Board), attaching an updated Table of 2005 Interim Rates, Tolls and Charges (the updated Table) for the Tariff. The updated Table incorporates a new PT Schedule of Service, effective May 1, 2005, to increase operating pressures on average by 1000 kPa at the January Creek interconnect located at LSD 10-27-054-14 W5M.

## **Nature of the Application**

On May 7, 2004, the Board issued Order U2004-136 approving the amendments to the NGTL Tariff General Terms and Conditions to incorporate the changes required to implement the PT Service until its expiry on December 31, 2005.

In the Application dated March 15, 2005, NGTL submits that the charge for service was determined in accordance with the methodology that the EUB approved in Order U2004-136. NGTL further submitted that the PT Rate is based on a reduced fixed operating and maintenance charge of \$35.00/day. In addition, that the charge for NGTL's gas requirements will be based on a PT Gas Rate of  $3.0 \times 10^3 \text{m}^3/\text{d}$  and will vary with NGTL's Gas Use Price.

NGTL put forward that in order to facilitate the increase in operating pressure, the January Creek Lateral will be tied into the high pressure NPS 48 Edson Mainline. Pursuant to the terms of the PT Service, the customer requesting the PT Service has provided a full contribution in aid of construction of \$700,000.00 plus GST for the construction of incremental tie-in facilities. Further, NGTL submits that there are no impacts to shippers within the area anticipated from the proposed increase in pressure at the January Creek interconnect.

It is understood that NGTL posted a notification of the requested PT Service on TransCanada's Alberta System Website and has not received any objections to the requested service. It is also recognized that NGTL has provided notice of this filing to shippers and to members of the Tolls, Tariff, Facilities and Procedures Committee (TTFP) via the TransCanada Alberta System Website. NGTL is directed to advise shippers and the TTFP of this Notice in similar fashion.
