On March 1, 2007, NGTL applied for approval of final rates, tolls, and charges for services on the Alberta System, effective April 1, 2007 (“2007 Final Rates”). NGTL amended its application on March 13, 2007. In its Notice of Application dated March 7, 2007 the Alberta Energy and Utilities Board (“Board”) sought submissions from interested parties regarding the application no later than March 14, 2007 and reply comments, if any, from NGTL by March 19, 2007.

NGTL received copies of submissions made by the Alberta Urban Municipalities Association, the City of Edmonton and the Office of the Utilities Consumer Advocate, BP Canada Energy Company, the Consumers Coalition of Alberta and Gas Alberta Inc. These parties each expressed an interest in the determination of the Application, but none identified any concerns with it or otherwise objected to the 2007 Final Rates.

In the absence of any intervener concerns or objections, NGTL requests that the Board continue to process and approve the application as filed.

NGTL will notify its shippers, the members of the Tolls, Tariff, Facilities and Procedures Committee and interested parties to NGTL’s 2005 GRA Phases 1 and 2 of the availability of this letter on TransCanada’s Alberta System Website at the address below:
